

Highlights of the Wisconsin Academy 2009–2010 Season

Founded in 1870, the Wisconsin Academy applies the sciences, arts, and letters to bring context, civilized discussion, and meaningful action to the most important issues of today. We create spaces—public forums, art galleries, publications—where citizens join together to examine the challenges of our times, suggest solutions, and look at the world in new ways. We celebrate and preserve Wisconsin's human, cultural, and natural resources. In this way the Wisconsin Academy connects people and ideas for a *better* Wisconsin—and we've been doing it for 140 years.

This year with our annual report, we're sharing with our members more of how our organization operates. After all, it's *your* Wisconsin Academy. And your support through membership and donations allows us to produce high-quality programs and share them with the public. Here are some program highlights from 2010:

The James Watrous Gallery

- received a second Partnership Grant from the Wisconsin Arts Board to share with the state the winners of the prestigious Wisconsin Arts Board Visual Arts Fellowship program
- was ranked fourth of 96 statewide applicants for NEA federal stimulus grant funds, resulting in a grant at the highest funding level available (\$25,000) with approval from the state of Wisconsin
- received materials on loan from three major institutions: The Renwick Gallery of the Smithsonian Institution, the Milwaukee Art Museum, and the Milwaukee Public Museum
- increased visitors from 9,737 last year to 10,263 this fiscal year while reducing overall expenses

Wisconsin People & Ideas Magazine

• remains the number one reason people join the Wisconsin Academy. (Anyone can join, and the magazine is free to all members.)

- completed its 56th continuous year of publication. The quarterly magazine remains the only statewide print publication in the nation that regularly features poetry, short stories, and artwork in a variety of media, as well as articles that cover science, technology, and the environment
- was distributed to 70 bookstores, 80 libraries, and all state elected officials
- collaborated with Portal Wisconsin on the multimedia Voices of Rural Wisconsin project in an effort to capture authentic and authoritative voices discussing rural concerns in our state

Academy Evenings

- presented a series of eight highly acclaimed "Wisconsin 2050: Pioneering the Future" public conversations at the Overture Center in Madison and another six in venues across the state: Wausau, Ashland, Milwaukee, Sheboygan, Menasha, and Hudson. Each of these programs stimulated and entertained attendees, with presenters offering solutions and directions for moving our state and world forward.
- downloads of Academy Evenings programs on portalwisconsin.org exceeded 20,000, and annual visits to our website topped 230,000.
- for the first time, 130 individuals joined Academy Evening presentations from the comfort of their home computers as they happened.

Patricia Brady retired in 2010 after a thirty-year career at the University of Wisconsin System, where she served as the UW System General Counsel since 2002. Before becoming general counsel, Brady served as deputy general counsel and senior system legal counsel for UW System. She is a regular speaker on legal issues in higher education, and has taught higher education law at UW–Madison.



Terry Brown is Provost and Vice Chancellor for Academic Affairs at UW–Parkside. As provost, Brown's duties include supervision of curriculum, teaching,

faculty appointments, academic resources, and support programs. In addition to overseeing the university's thirty-three undergraduate major and three Masters program, she supervises the Center for Community Partnerships and the UW–Parkside Library, as well as Advising and Career Services, Campus Technology Services, and Student Support Services.



Joseph Heim is a former chair of the Department of Political Science/Public Administration at UW–LaCrosse and current Director of the Public Adminis-

tration Program at the university. A political analyst for WKBT–TV (LaCrosse) and occasional guest analyst on WPR, Heim is a Governor's Appointee to the Wisconsin Educational Approval Board (2003–present) as well as a member of the Wisconsin Judicial Campaign Integrity Committee (a State Bar committee) and a number of professional associations including the American Society of Public Administration and the Wisconsin Political Science Association.

Why are you a member of the Wisconsin Academy?

My family has always placed a high value on education. Growing up in the college town of Appleton, I attended lectures and regularly heard famous and not so famous speakers at Lawrence University. Because the liberal arts were valued by my family, I chose the liberal arts for my own education. A liberal arts education was a way to continue to learn and explore, look at different ideas, get a bit uncomfortable, and be involved. The Wisconsin Academy embodies the liberal arts with its commitment to the sciences, arts and letters. I also like its lofty goals—to connect people and ideas for a better Wisconsin—and its sensitivity to respect and share the state's intellectual resources, both public and private.

How has the Wisconsin Academy been meaningful to you?

It has been educational for me. The people I have met through the Academy have helped me grow. They share similar, broad interests and are involved in bettering their own communities.

Which aspects of the Academy matter most to you?

I support the communication of ideas. The magazine, lecture series, gallery for Wisconsin artists, and Wisconsin Idea public policy projects all do that. The Academy has originated meaningful conversations to the attention of a broad audience on many topics, helping us better understand the politics and culture of the Middle East, energy, early childhood brain development, even how to age better. Blogs, computer screens, and newspapers can't take the place of face-to-face conversations between people and experts. These important dialogs add dimension to your set of beliefs.

Do these programs have an impact on your part of the state?

Let me tell you about a program that was part of a series of lectures in the Fox Valley called "Brain to Five," of which the Wisconsin Academy was a catalyst. Dr. Richard Davidson [Wisconsin Academy Fellow, 2004] of UW–Madison's Waisman Center spoke to K–12 teachers and more than five hundred people in our community about how happy people are *compassionate* people. This has inspired a project in our public schools where our ten thousand children will create their picture of compassion on a six-by-six inch square, and write a paragraph about how that picture represents their concept. Then each of these will be displayed in our Trout Museum of Art to share with all the children's parents and the community at large. Imagine the lines of parents wanting to see their child's square. Think about the impact of twenty to forty thousand people in our community talking about compassion.

What would you like to see the Wisconsin Academy do more of?

Adapt to the ways people are receiving information. Engage with other organizations. Help make more people aware of how important an addition Academy membership is to their intellectual life. For example, I don't know anything about basket weaving, which was featured on the front of the fall 2010 magazine. But I can be sure it will make for interesting conversation, and I will learn something about a Wisconsin asset.

Why should others become a member or invest in the Wisconsin Academy?

The Academy is a way for people to help develop themselves. It is a vehicle for us to tackle important issues. It is for anyone who cares about Wisconsin and its intellectual and cultural assets. And it is about being an educated voter and citizen. Education is a great freedom that should be exploited. I like the way the Academy reaches out to all citizens of Wisconsin. To fulfill this mission requires resources to expand programs and visibility. I have invested a lot of time and effort in the cause of sharing knowledge for a better society, and want to see the Academy succeed and continue to expand so that others can benefit from these programs.


